Hall Risk Assessment

Introduction

Bedford Academy of Dance, under guidance from the Royal Academy of Dance and the management of St Andrew's Parish Church and in line with Government Guidelines supply this Risk Assessment that confirms the requirements of safe dance while at St Andrew's Parish Church.

All parents and guardians of children planning to attend dance lessons at the St Andrew's Parish Church location must follow the guidelines and Risk Assessment set out in this document.

Not following this guidance may result in your child being refused entry to the location and lesson. You will also still be charged for the lesson.

With your understanding, support and by following this guidance, we will ensure that your children get the best opportunity to carry on dancing and enjoy their lessons in a safe and secure manner.

We have a zero tolerance policy of any verbal or physical abuse to our dance teaching staff whilst trying to carry out their duties for lessons.

Location

St Andrew's Parish Church has set out its own specific requirements for use of their facilities and this guidance document has been written to ensure we follow their specific requirements.

If we do not follow their guidelines, it may result in access to the Church Hall being denied and all dance lessons being cancelled until further notice.

Dancing Procedures

Dance Wear

- 1. Your child must be dressed in their dance outfit ready to dance. If they are not dressed, they will not be allowed to enter.
- 2. All dancers must wear some form of footwear during their lesson. This could be ballet shoes, dancing socks or tote socks. Your child can wear normal trainers or shoes and carry their dance footwear in a bag and change them inside the hall. For younger children, teaching staff / assistants will help them to change their footwear at the start and end of each lesson.
- 3. At the end of the class, children will collect all belongings and must leave as soon as is reasonably practicable to be collected by the parent/guardian in the foyer area.
- 4. All personal attire, equipment or props used for lessons must be brought labelled with your child's name on it, where reasonably practicable.

Dancing / Lessons

- 1. A register for each class is maintained by the teacher and for the purposes of safety, security and safeguarding compliance.
- 2. Please remember that dance is a physically demanding activity and we strive to provide a safe and supportive environment where everyone can learn, teach, and perform with confidence. Teaching staff / assistants will carry out warm ups and warm downs during each lesson.
- 3. Physical contact may be necessary by members of the teaching faculty due to the nature of dance and for your child's growth, development and safety. This will always be carried out in an appropriate manner and with your child's best interests in mind.
- 4. If your child requires to use the toilet in the lesson, teaching staff / assistants will take them to and from the toilet one at a time. Please ensure that you highlight any concerns around personal toiletry / hygiene / sanitary issues that your child may have or require prior to the lesson start.
- 5. Your child can bring water into the lesson in their own labelled, water bottle. See Welfare Facilities for more details.
- 6. Food and snacks can be consumed on site by children at the end of or between lessons as appropriate. See Welfare Facilities for more details.
- 7. If any parent / guardian does not comply with the requirements of the lesson or access / egress procedures, your child will be refused access to the lesson. If a parent or guardian continues to ignore /breach the procedures set out in this document, then it may lead to a complete removal of further lessons for your child. You will still be liable for a terms fees and no refunds will be made.

Safe Access Procedures

The following information outlines the specific access / egress requirements and actions for dropping off and picking up your child.

Access will always be through the main doors to the Church on Kimbolton Road as shown below. Egress will always be through the rear doors that lead to the car park on St Alban Road.





Egress Point

Access - Drop off Point - Kimbolton Road

Access

- 1. All children will arrive and enter through the main door on Kimbolton Road where the dance teaching staff will be located to receive them.
- 2. Only children will be allowed to enter and will then be escorted to the main hall for their lesson.
- 3. No parents / guardians will be allowed access to the Church / main hall at any time.
- 4. If your child has specific medical issues or needs to take medication during lessons, then please read the information under Medical Requirements below.
- 5. If you believe you may be delayed in dropping off your child, please text or call to give advance warning of your delay.
- 6. To ensure you maintain government social distancing guidelines and to comply with the requirements of the Church, please do not stand outside talking to other parents / guardians.

Egress

- 1. The pick-up point is located at the St Alban Road car park side at the rear of the Church, please wait outside in the main car park to receive your child.
- 2. All children will exit through the rear doors located at the end of the corridor next to the kitchens which leads to the rear car park from the St Alban Road side.
- 3. Only teaching staff will be allowed back through that exit door to re-enter the Church / hall.
- 4. No parents / guardians will be allowed access to the Church / main hall from this exit point.
- 5. If there is inclement weather, then please ensure you bring umbrellas.
- 6. Please ensure you arrive in plenty of time to pick up your child to avoid disruption to the egress procedures.
- 7. If you believe you may be delayed in picking up your child, please text or call to give advance warning of your delay.

Medical Requirements

Medical Needs, Conditions or Medication

If your child has specific medical needs, issues or medication that they need during their lesson then please ensure you discuss this with Miss Hannah prior to the beginning of the term, so a strategy can be organised to manage the medical needs of your child.

Covid 19

The government has removed the remaining domestic restrictions in England, although there are still steps you can take to reduce the risk of catching and spreading COVID-19:

- Get vaccinated.
- Let fresh air in if meeting indoors, or meet outside.
- Consider wearing a face covering in crowded, enclosed spaces.

We will maintain a watching brief of the guidance and update this policy, and inform everyone, in line with current Government guidance.

Emergency Procedures

In the event of an emergency on site, all children, staff and visitors must follow the on-site emergency and evacuation arrangements and will be directed to the site assembly point.

Communication with the emergency services will be managed by the Church on-site staff / dance teaching staff with the local emergency services, as required. Parents / guardians will be informed as soon as possible to organise pick up if the situation is not resolved and access back into the building is prohibited.




